Tournament Rules:

- Players will start with 15,000 in tournament chips.
- A Big Blind ante will be used for this event. The ante will not be counted for pot pre-flop.
- On-Site Registration and rebuys are available until the start of Level 7 of this event. Approximately 8:15pm.
- Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
- Levels will last 20 minutes each. Final table will be 30 minutes.
- TDA rules apply. Tournament Directors decisions are final and without recourse.
- Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters.
- Redraw at 24 and 8 players or at Tournament Directors discretion.
- Winners will be paid in casino chips.
- All tax laws foreign and domestic apply. Winners must show a valid ID to collect winnings. Residents of foreign countries without a U.S. tax treaty will be subject to withholding. Pursuant to new IRS regulations, W-2G or 1042 forms will be issued for all tournament winnings of \$5,000 or more (net of buy-in amount).
- Tournament prize pools may be modified if all remaining players unanimously agree.
- \$150 will go into the prize pool. \$34 is the registration fee. \$16 will go towards the staff token pool.
