- A single ante will be paid from the big blind for each hand. The ante is paid before the big blind. The ante will not reduce.
- On-Site Registration and unlimited Re-Entries are available until the start of Level 9 of this event. Approximately 5:30pm.
 If player has been diminated from the taumement, they may Be Enter the event. Alternates and late sign upp will actor.
- If player has been eliminated from the tournament, they may Re-Enter the event. Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
- Levels will last 30 minutes each. Seating may be limited for this event.
- Dinner break will be from 6:30pm 7:10pm.
- TDA rules apply. Tournament Directors decisions are final and without recourse.
- Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters.
- Redraw at 27 and 9 players or at Tournament Directors discretion.
- Winners will be paid in casino chips.
- All tax laws foreign and domestic apply. Winners must show a valid ID to collect winnings. Residents of foreign countries
 without a U.S. tax treaty will be subject to withholding. Pursuant to IRS regulations, W-2G or 1042 forms will be issued for
 all tournament winnings of \$5,000 or more (net of buy-in amount).
- Tournament prize pools may be modified if one table remaining. All players must unanimously agree.
- \$110 will go into the prize pool. \$26 is the registration fee. \$14 will go towards the staff toke pool.
