Tournament Rules:

- Players will start with 10,000 in tournament chips.
- A single ante will be paid from the big blind for each hand. The ante is paid before the big blind. The ante will not reduce.
- On-Site Registration and unlimited Re-Entries are available until the start of Level 7 of this event. Approximately 2:30pm.
- If player has been eliminated from the tournament, they may Re-Enter the event. Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
- Levels will last 30 minutes each.
- TDA rules apply. Tournament Directors decisions are final and without recourse.
- Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters.
- An entry to the PokerNews Cup \$1,000,000 guaranteed main event will be awarded for every \$1,100 in the prize pool. Remaining prize money will be distributed to the next highest placing finisher.
- All tax laws foreign and domestic apply. Winners must show a valid ID to collect winnings. Residents of foreign countries without a U.S. tax treaty will be subject to withholding. Pursuant to IRS regulations, W-2G or 1042 forms will be issued for all tournament winnings of \$5,000 or more (net of buy-in amount).
- \$150 will go into the prize pool. \$34 is the registration fee. \$16 will go towards the staff toke pool.
